Title: Logistics Coordinator - Conservation Corps North Carolina

**Starting Salary Range:** The starting salary range for this position will be in the \$21.63 to \$22.28 per hour range, depending on experience, education, and skills relevant to the position. ## **Conservation Corps North Carolina:**

Conservation Legacy is a nationwide non-profit. The Corps programs within the organization engage participants in diverse conservation and community projects that serve public and private lands. These projects provide opportunities for personal and professional development and strive toward a high priority of needs for public land managers and community partners. Through the mission of engaging future leaders who protect, restore and enhance our nation's lands through community-based service; Conservation Legacy works toward a world with healthy lands, air and water; thriving people and resilient communities.

CCNC is a program of Conservation Legacy that partners with public land managers in North Carolina to engage motivated young adults (ages 18-30) to complete challenging and impactful conservation service projects throughout the region. Projects may include trail construction & maintenance, habitat improvement, hazard fuel reduction, and ecological restoration. Crews may also complete technical and/or specialized projects depending on project partner needs.

Projects take place across North Carolina, including work with the US Forest Service, the National Park Service, State Parks, and other land managers. During their time in the field, CCNC field crews camp overnight and work outdoors in all types of weather conditions, performing heavy manual labor related to environmental conservation and restoration projects. These hands-on projects include visitor access improvements, trail construction and maintenance, habitat restoration, invasive species treatments, historic restoration, disaster relief, and much more. Most projects require hiking out to remote work sites for the day with tools, equipment, and day pack. We are a team of fun, inclusive and passionate individuals who are seeking someone who is willing to have a great time doing hard work in a diverse field!

# **Position Summary:**

The Logistics Coordinator's primary responsibility is to support logistics for CCNC programming, with an emphasis on equipment, tools, vehicles, gear, PPE, uniforms, and food. The position will support CCNC adult and youth programs, including crew models and individual placements. Additionally, the Logistics

Coordinator will assist with the development and implement field-based leadership and technical skills trainings to support the development of CCNC's field staff and corps members - as well as completing field visits to provide support to crews, field leadership and partners. Some evening and weekend work required; a flexible schedule is a must. Reports to the Program Manager.

#### **Outcomes & Functions of Position:**

# **Program Logistics**

- Manage and maintain an organized, clean, and efficient operations facility, including facility maintenance and repair.
- Create, edit and distribute tool lists for each crew.
- In conjunction with other program staff, supervise rig-ups and de-rigs for all field operations.
- Maintain, repair, inventory, and purchase tools, chainsaws, camp equipment, PPE, and other supplies related to field operations.
- Manage the repair and preventative maintenance of fleet vehicles and trailers.
- Maintain and create organizational systems for logistical management.

# **Field Support and Risk Management**

- Visit the field as needed for technical and programmatic assistance, including overnight stays.
- Teach and enforce all CCNC and Conservation Legacy policies and procedures.
- Respond to crew emergency situations and evacuations, including last-minute travel and overnight stays.
- Participate in staff and crew trainings, both as a trainer and/or a trainee including, but not limited to trails, chainsaw, rigging, herbicide, and leadership training.
- Participate and be a leader in the On-Call system with Eastern Region Corps.
- Aid Program Manager in tracking, submitting and response to Incident Report Tracking system.

#### **Conservation Skills**

- Technical proficiency in a variety of conservation skills, including B-level chainsaw skills, crosscut saw, trail maintenance and construction, fire/fuels reduction, invasive species management.
- Proficiency in variety of project models and camping setups, especially backcountry travel, working at altitude, and associated risk management concerns.
- Ability to inform and enforce risk management practices necessary for the complexity and volume of the adult program.

#### **Other Duties**

- Participate in the recruitment and onboarding of crew members and leaders as needed.
- Participate in program promotional activities including recruitment events.
- Manage credit card, petty cash, and other expenses related to program operations.

• Foster a collaborative approach to communication and operations with the crew operations team.

- Preferred experience with any, some, or all of the following: trail construction & maintenance, chainsaw operations & maintenance, crosscut work, herbicide use, hand tool maintenance, and facilities maintenance.
- Great organizational and problem-solving skills.
- Ability to carry out assigned work independently or with minimal supervision, while also functioning in a team environment and seeking assistance when needed.
- Desire to work with youth, young adults, and BIPOC communities.
- Ability to successfully work in a fluid, changing work environment.
- Ability to operate Microsoft Office programs and applications, or similar platforms.
- Ability to keep others and oneself, in remote locations, accountable to expectations.
- Valid Driver's License and Insurable Driving Record per Personnel Policies.
- Must be able to pass the organization's criminal history check requirements.
- Exhibits the ability to effectively collaborate with diverse teams or with a variety of populations, including those underrepresented at our organization and those of BIPOC communities.

#### **Preferred Qualifications:**

- Strong conflict resolution and team building skills preferred.
- Current Wilderness First Responder certification, or willingness to acquire certification within 3 months of hire.
- Advanced experience in fleet management, small engine repair, and hand tool repair and maintenance
