Title: Director of Finance

### **Organizational Summary:**

Conservation Legacy is a nationwide non-profit. The Corps programs within the organization engage participants in diverse conservation and community projects that serve public and private lands. These projects provide opportunities for personal and professional development and strive toward a high priority of needs for public land managers and community partners. Through the mission of engaging future leaders who protect, restore and enhance our nation's lands through community-based service; Conservation Legacy works toward a world with healthy lands, air and water; thriving people and resilient communities.

## **Position Summary:**

The Director of Finance position is responsible for managing the finance team and overseeing the development of monthly and year-end financial statements. The position establishes and monitors internal controls for monitoring assets, capital investments, controlling costs, and liquidity. The position ensures compliance with applicable regulations (GAPP, CFR, etc. mandate). The position also supports the long-term strategies for the organization. The Director of Finance directly supervises the Controller and provides support for the training and development of finance staff. The Director of Finance receives support from a contract Chief Financial Officer.

- Oversees the finance department's day-to-day functions
- Responsible for delivery of accurate and timely monthly and end-of-year financials
- Manages internal controls
- Generates financial reports for staff, board, and other stakeholders
- Audits and analyzes expenses
- Supports the annual audit process and engages with independent auditors
- Advises organizational leaders on financial goals and targets
- Ensures the finance department is organized and staffed to support the organization's mission and goals.
- Monitors and manages cash flow and line of credit
- Responsible for identifying and mitigating risks
- Work collaboratively with other staff and departments for the purposes of budget
